A RESOLUTION AUTHORIZING THE VILLAGE OF MANTUA TO FILE
AN APPLICATION WITH THE STATE OF OHIO DEPARTMENT OF
DEVELOPMENT FOR TIER ONE DOWNTOWN REVITALIZATION
PLANNING FUNDS UNDER THE OHIO SMALL CITIES COMMUNITY
DEVELOPMENT BLOCK GRANT COMPREHENSIVE DOWNTOWN
REVITALIZATION PROGRAM AND DECLARING AN EMERGENCY

WHEREAS, the State of Ohio, Department of Development, provides financial assistance to local governments for the purpose of downtown revitalization planning under the Ohio Small Cities Community Development Block Grant Comprehensive Downtown Revitalization Program; and

WHEREAS, the Village of Mantua desires to make application for financial assistance for downtown revitalization planning under the Ohio Small Cities Community Development Block Grant Comprehensive Downtown Revitalization Program; and

WHEREAS, the Village Council previously pledged its financial support in the amount of Twenty-Five Thousand Dollars (\$25,000) for downtown revitalization planning by adopting Resolution 2007-08, which provides the Twenty-One Thousand Dollars (\$21,000) needed for the Village to make application for financial assistance under the Ohio Small Cities Community Development Block Grant Comprehensive Downtown Revitalization Program;

NOW, THEREFORE, BE IT RESOLVED by the Council for the Village of Mantua, County Portage, State of Ohio, that:

SECTION 1: That Village Council authorizes the Mayor to make application to the State of Ohio, Department of Development, for Tier One Downtown Revitalization Planning Funds under the Ohio Small Cities Community Development Block Grant Comprehensive Downtown Revitalization Program, and to provide all information and documentation required in said application for submission.

SECTION 2: That Village Council hereby approves application to the State of Ohio, Department of Development, for Tier One Downtown Revitalization Planning Funds under the Ohio Small Cities Community Development Block Grant Comprehensive Downtown Revitalization Program in the amount of Fifteen Thousand Dollars (\$15,000).

SECTION 3: It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its Committees that resulted in such

formal action were in meetings open to the public in compliance with all legal requirements, including Section 121.22 Of the Ohio Revised Code.

SECTION 4: This Resolution is hereby declared to be an emergency measure, effective immediately upon its passage by Council and approval by the Mayor to enable the Village to meet the deadline for filing for the grant.
